The Ministry of Education (MoE) has received financing from the German Federal Government through KfW Development Bank (KfW) and from the European Union (EU) through their Regional Trust Fund in Response to the Syrian Crisis (EUTF). The MoE intends to apply parts of this funding to the procurement of Vocational Equipment under the Contract for "Procurement of Vocational Equipment for School Construction Programme".

Therefore, the Ministry of Education now invites sealed bids from bidders for the supply and delivery of the goods specified in this Bidding Documents.

Interested bidders are invited to bid for the supply, installation, and commissioning for the Vocational Equipment (hereinafter referred to as "Goods") for 4 out of 18 schools (Phase 1). The required Vocational Equipment for the 18 schools will be tendered in phases based on the actual completion date of the respective schools.

The first four schools of phase 1 which are the subject of this bid, are funded by the European Union (EU).

Bidders who submit responsive offers for phase 1 will be invited to participate in the following 2 phases by only filling the BoQs. For any new bidders that are invited by the MoE to participate only in phase 2 and 3 they shall complete the full documents.

All questions must be submitted and received no later than **14 calendar days before the submission deadline.**

PART 1 – Bidding Procedures (إجراءات المناقصة)

1.1 Definitions (تعريفات)

- «KfW» هي وكالة التمويل التي يتم من خلالها تمويل التعاون المالي الألماني. وتقع على عاتقها مسؤولية تنفيذ البرنامج، بما في ذلك المدارس الممولة من الاتحاد الأوروبي.
 - «EU» يعني الاتحاد الأوروبي.
 - «MoE» تعني وزارة التعليم وفي هذه الوثائق باسم المشتري.
 - كلمة "المناقص" تعني الشركة أو مجموعة الشركات المتقدمة للعبء. الشركة المتقدمة (المناقص) التي يتم إحالة العطاء لها تسمى: "المورد".

1.2 Instruction to Bidders (تعليمات للشركات المتقدمة)

The tendering shall be carried out in accordance with the latest version of KfW Procurement Guidelines, a copy of which is available for download from the KfW website. [Procurement regulations | KfW Development Bank \(kfw-entwicklungsbank.de/Service/Procurement-Regulations/\)](http://www.kfw.de/Service/Procurement-Regulations/)

1. The "Purchaser" is the Ministry of Education of the Hashemite Kingdom of Jordan.
2. The EU sections of this Contract are financed by the European Union through KfW from their Regional Trust Fund in Response to the Syrian Crisis (EUTF).
3. The "Consultant" for the purposes of this Purchase Order means the Joint Venture Dorsch International Consultants GmbH as the Leading Partner, with AHT GROUP AG and DAR AL OMRAN Planning, Architecture and Engineering.

Qualification and Responsiveness Requirements:

- Company Registration (At the time of collecting documents)
- Professional license (At the time of collecting documents)
- Completely filled-out FORM 1 – Declaration of Undertaking
- Completed FORM 2 – Compliance sheets (Technical Schedules) for the applicable lot
- Completely filled-out, stamped FORM 3– BoQs for the applicable lot (and total price on the last page of the form signed)
- Completed FORM 4 – Confirmation to providing standard Manufacturing Warranty as per the technical specifications.

The purchaser shall reject bids that are not substantially responsive to the qualification requirements of this RfQ document.

1.3 Award Criterion and Opening of Bids (إجراءات التقييم و إحالة العطاء)

The process of evaluation of the Bid and subsequent award shall be as follows:

1. This RfQ is divided into 4 lots, the Bidder may choose to bid for one or more lots, however the bidder shall fill the BoQ for all schools for the lots they intend to participate in.

2. The Purchaser reserves the right to award all lots or any lots for the same bidder or different bidders.
3. The Bidder shall complete all items in the Bills of Quantities for the Lots they intend to participate in. Partial bids per lot will not be accepted and will lead to the rejection of the complete lot.
4. All timely bids received will be publicly opened at the date and time advised by the Purchaser and stipulated under the "Invitation to Bid"
5. The Contract will be awarded to the lowest compliant total priced Bid excluding sales tax and custom duties, and the amount of Contract award will be total price excluding sales tax and custom duties. Sales tax and custom duties if any shall be reimbursed by the ministry of education as per the letter of taxation in section 1.5.
6. Envelopes containing the bids will be opened by a committee in a public opening session on the date specified in the Invitation to Bid at 15:00 hours local time.
7. The price offer in the bid shall be **valid for 120 days** from the submission date.
8. The bid shall be in accordance with the stamped BoQ from MoE provided in this document and it shall be signed and stamped by the Bidder.
9. If there is a discrepancy between the unit price and the line item total that is obtained by multiplying the unit price by the quantity, the unit price shall prevail and the line item total shall be corrected, unless in the opinion of the Purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the line item total as quoted shall govern and the unit price shall be corrected;
10. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
11. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error.

معايير إحالة العطاء و فتح العروض

سيكون تقييم العروض و لاحقاً الإحالة على النحو التالي:

We recognise and accept that KfW only finances projects of the Project Executing Agency ("PEA")³ subject to its own conditions which are set out in the Funding Agreement it has entered into with the PEA. As a matter of consequence, no legal relationship exists between KfW and our company, our Joint Venture or our Subcontractors under the Contract. The PEA retains exclusive responsibility for the preparation and implementation of the Tender Process and the performance of the Contract.
2. We hereby certify that neither we nor any of our board members or legal representatives nor any other member of our Joint Venture including Subcontractors under the Contract are in any of the following situations:
 - 2.1) being bankrupt, wound up or ceasing our activities, having our activities administered by courts, having entered into receivership, reorganisation or being in any analogous situation;
 - 2.2) convicted by a final judgement or a final administrative decision or subject to financial sanctions by the United Nations, the European Union or Germany for involvement in a criminal organisation, money laundering, terrorist-related offences, child labour or trafficking in human beings; this criterion of exclusion is also applicable to legal Persons, whose majority of shares are held or factually controlled by natural or legal Persons which themselves are subject to such convictions or sanctions;

This shall become an integral part of the contract. Failure to submit may result in exclusion from the awarding procedure. 

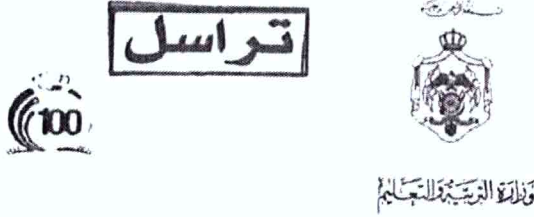

If any proceedings are brought or any claim is made against the Purchaser arising out of the matters, the Purchaser shall promptly give the Supplier a notice thereof, and the Supplier may at its own expense and in the Purchaser's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.
14. If the Supplier fails to notify the Purchaser within twenty-eight (28) days after receipt of such notice that it intends to conduct any such proceedings or claim, then the Purchaser shall be free to conduct the same on its own behalf.
15. The Purchaser shall, at the Supplier's request, afford all available assistance to the Supplier in conducting such proceedings or claim, and shall be reimbursed by the Supplier for all reasonable expenses incurred in so doing.
16. The Supplier shall maintain, for so long as may be necessary to cover its obligations and liabilities under or in connection with this Agreement, insurances, including vehicle insurance, with limits of indemnity of not less than the sums stated in **Clause 12** above, for any one occurrence or series of occurrences arising out of any one event in respect of the Supplier's liability. the Supplier's public/third party liability, arising out of or in connection with the Supply Services and any other risks or events stipulated in the Agreement or required by the laws of the Country. Transport insurance for Goods shall be at least 110% (one hundred and ten percent) of the Accepted Contract Amount and shall cover "all risks" basis and should include war risks and strike clauses.
17. The Supplier shall produce for inspection documentary evidence that the insurances required by **Clause 16** are being properly maintained when required to do so by the Consultant The Purchaser, by notice sent to the Supplier, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.
18. Except in cases of criminal negligence or wilful misconduct,
 - a) The Supplier shall not be liable to the Purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Supplier to pay liquidated damages to the Purchaser; and

- b) The aggregate liability of the Supplier to the Purchaser, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the Supplier to indemnify the purchaser with respect to patent infringement.
19. The Goods that are complete and ready for shipment within twenty-eight (28) days after the Supplier's receipt of notice of termination shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect:
- a) To have any portion completed and delivered at the Contract terms and prices; and/or
- b) To cancel the remainder and pay to the Supplier a mutually agreed amount for partially completed Goods and Related Services and for materials and parts previously procured by the Supplier.
20. Termination of this Agreement howsoever arising shall be without prejudice to the rights and remedies of either Party in relation to any negligence, omission or default of the other, prior to such termination.
21. In performing his services according to this Agreement, the Supplier will not provide bribes, gifts, direct or indirect payments or kickbacks of any kind, or will offer to provide or pay such, to employees or representatives of the Consultant or the Purchaser or authority or government officials or political parties for purposes of influencing any act or decision or inducing such authority or government official to use his influence with the authority, government or instrumentality thereof to effect or influence any act or decision, or which are otherwise illegal under any applicable law and, further, shall comply with the Declaration of Undertaking signed and stamped by him and attached as annex hereto.
22. If a Force Majeure⁶ situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
23. In the case of a dispute between the Purchaser and a Supplier, the dispute shall be referred to adjudication or arbitration in accordance with the laws of the Purchaser's country.
24. Price Adjustments are not allowed under this Contract.
25. Within 14 (Fourteen) days after receipt of the notification of award from the Purchaser, the successful Supplier shall furnish to the Purchaser a Performance Security in the form of a bank guarantee in an amount of 10% (ten percent) of the Contract price. The performance security shall be denominated in Jordanian Dinar. The sample form of the Performance Bank Guarantee is provided in Section 3.4.
26. The Performance Bank Guarantee to be provided by the successful Supplier shall be an unconditional bank guarantee issued either (a) by a reputable bank located in the country of the Purchaser, or (b) by a foreign bank acceptable to the Purchaser.
27. Failure of the successful Supplier to comply with the requirements of this Performance Guarantee shall constitute sufficient grounds for the annulment of the award.
28. The Performance Security shall be discharged by the Purchaser and returned to the Supplier not later than twenty-eight (28) days following the data of the Completion of the Supplier's performance obligations under the Contract.
29. If the Supplier fails to deliver any or all of the Goods by the Date(s) of delivery or perform the Related Services within the period specified in the Contract, the Purchaser may without

prejudice to all its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to the percentage specified in the table below of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the percentage specified in the table below. Once the maximum is reached, the Purchaser may terminate the Contract. These damages shall not relieve the Supplier from his obligation to complete the Services, or from any other duties, obligations, or responsibilities which he may have under the Contract.
